The Annual meeting of the Royalton Hartland Community Library was held on Monday, July 11th at 7:00 PM in the upstairs meeting room at the library.

The board welcomed Regina on board. Carolyn Wagner, Notary Public administered the Oath of Office to the newly elected Trustees.

Library Director's Report: Sonora presented the annual report which included yearly totals for circulation, programming and much more. The report is on file at the library.

Treasurer's Report: Debbie reported that she has signed checks for the staff not on direct deposit. Otherwise, things are tracking normally.

The 2016-17 budget was reviewed and approved after a motion from Ken and a second from Gretchen Lang.

Building and Grounds: The electrical work has been completed. This includes installation of outlets outside and upstairs. Tree trimming will be done by the village on a routine basis.

Friends: Rebecca Schweigert reported that a member of the Youngstown Friends attended a Friends meeting and offered information which will be helpful to our Friends group as they move forward to become more accountable. She reported that the Memorial Day book sale had fewer people attending, possible because there was not a basket sale and fewer boaters in attendance. On the up side, people appreciated the sale being in the upstairs room. Rebecca also said there will be a book sale this weekend at the Music in the Park event.
